### 12.2 PERSISTENCE AND DEGRADABILITY

For inorganic substances no degradation test needs to be performed.

However, calcium chloride is not expected to undergo photolysis or biodegradation.

### 12.3 BIOACCUMULATIVE POTENTIAL

Calcium chloride is easily dissociated into calcium and chloride ions and both ions are essential constituents of the body of all animals hence if a high amount would be taken up this is regulated by the body. Bioaccumulation of calcium chloride is consequently not expected.

### 12.4 MOBILITY IN SOIL

Calcium chloride is soluble in water and its vapor pressure is negligible.

Calcium chloride is not expected to be absorbed in soil due to its dissociation properties and high water solubility. As for the behaviour of calcium in soil, the calcium ion may bind to soil particulate or may form stable inorganic salts with sulphate and carbonate ions. The chloride ion is mobile in soil and eventually drains into surface water because it is readily dissolved in water.
